## Part A – Terms & Conditions for Parents

### 1. Principle

- Your child has been loaned an iPad, Charger, Apple Pencil & Case to enhance their education. This will be referenced as “Device”.
- Parent/Guardian understands that the device is an educational tool for my child and will not use it for personal use.
- This agreement does not give the Student or Parent/Guardian ownership of the device. St John's School retains ownership of the device.

### 2. Usage at home

- The Parent/Guardian has a responsibility to supervise the use of the device outside of school.
- The Parent/Guardian has a responsibility to make sure your child has charged the device fully for each school day.
- It is the responsibility of the Parent/Guardian to discuss safe and appropriate use of the device. (Please refer to the St John's School website for resources.)
- The Parent/Guardian understands that the device is an educational tool for my child and will not be used for personal use or ANY social media platforms.
- The Parent/Guardian will not allow any other persons but the student to use the device at home.
- The Parent/Guardian will not use the device to purchase any Movies, Music Television, Apps or any other media.

## 3. Hardware

- Parent/Guardian will not attempt to repair the device in anyway.
- Parent/Guardian will report any problems or damage immediately to my child's teacher.
- Parent/Guardian will not attempt to change the Hardware of the device.

## 4. Software

- Parent/Guardian will not attempt to change the configuration of the software.
- Parent/Guardian will not attempt to download programs from the internet to the device.
- Parent/Guardian will not attempt to remove any programs or files from the device.
- Software updates and applications will be managed by St John's School. Apple ID accounts should not be tampered with.

## 5. Damage & Repairs

- Damages to the device will be expected and repairs are quoted based on the findings.
- Damage caused by misuse will incur 100% payment of replacement or repair.
- Accidental damage will incur 50% payment and 50% from St John's.
